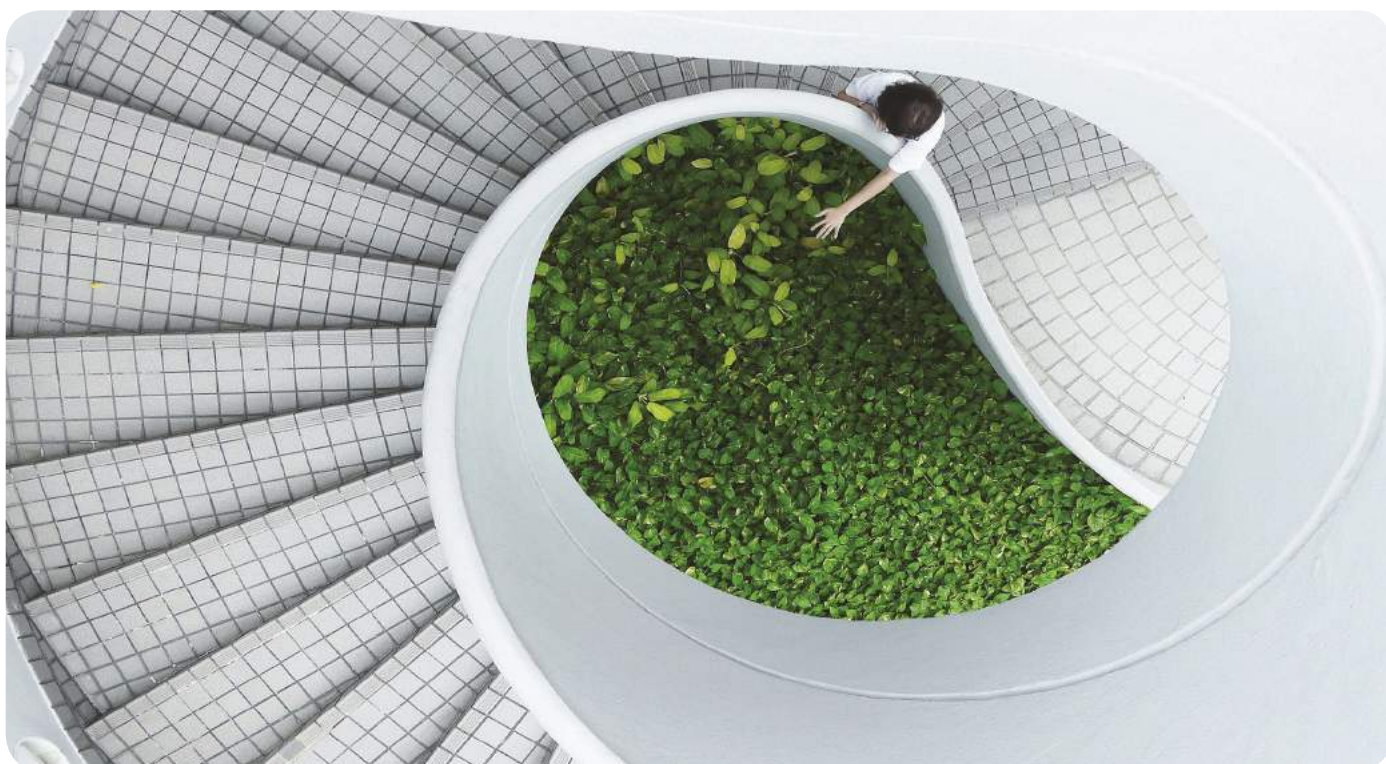

The following points are the most important criteria that prove our competence in large-scale and complex cleaning projects.

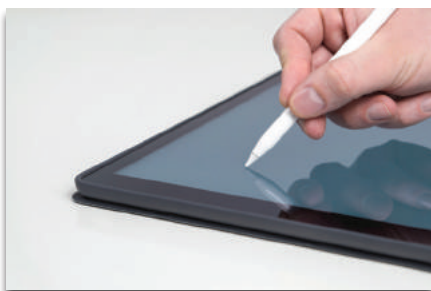
### We employ expert, experienced managers

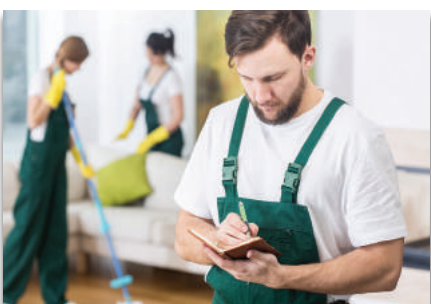


### We operate quality management system

### Well organized systems and precision are our basic principles

Each workflow is built up of detailed steps. Cleaners receive a daily cleaning schedule, divided by buildings and rooms detailing their tasks and scheduling. Our company employs technological instructions to ensure the highest quality of our workflows. Technology instructions control the workflow at operational level.

Our cleaning staff is employed with a full-time contract. Their wages are set above the minimum wage. When employing workers, we fully comply the conditions of legal employment.

## We use modern equipments

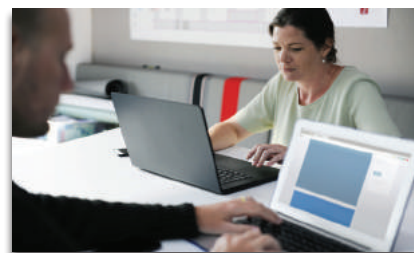
